

REGULATION

Art.1 Subject

In its efforts to promote Research and Innovation and for enhancing the individual competence of researchers, Fondazione Ri.MED presents itself as a Host Institution, according to the Ri.MED Charter and its Gender Equality Plan.

Thus, it will allow access to the appropriate facilities and space for conducting research, in a dynamic and innovative environment.

Art.2 Eligibility criteria

A proposal application will only be considered eligible if the applicant respects the eligible criteria set by the call for proposals for which the proposal has been submitted.

The proposal must comply with ethical principles.

Art.3 Submission of application

The proposal template and a detailed scientific CV must be submitted, before the submission deadline indicated in the dedicated Ri.MED web page, at the following e-mail addresses: hi@fondazionerimed.com and the one of the Principal Investigator/Group Leader identified by the applicant as Ri.MED scientific referent.

It is at the discretion of the Group Leader or Principal Investigator of the selected research group to decide, whether to accept or not a project proposal submitted after the submission deadline indicated in the dedicated Ri.MED webpage, or with an incomplete application form.

Art.4. Evaluation and selection of proposals

The Group Leader/Principal Investigator of the selected Ri.MED Research Group will evaluate the project proposals.

The evaluation will consider:

- the scientific and/or technological excellence,
- the scientific relevance to the selected Ri:MED Foundation's Research Group;
- the innovative character of the proposal against the state of the art;
- the scientific track-record of the applicant as regard the proposed scientific project.

If the proposal matches the interest of the selected Ri.MED Research Group, the applicant will be contacted for an Interview with the Group Leader or Principal Investigator of the selected group, as a last step of the evaluation process.

Art.5. Privacy policy

Personal data provided by applicants will be collected at Fondazione Ri.MED for the purposes of managing both applications evaluation and selection, and will be processed within the limits and in compliance with the Italian Legislative Decree No. 196 of 30 June 2003 “Personal Data Protection Code” and the EU Regulation 2016/679 of the European Parliament and of the Council of 27 April 2016 (General Data Protection Regulation – GDPR).

Art. 6 Confidentiality

All proposal applications and the information here contained shall be treated confidentially by Fondazione Ri.MED.

Moreover, if at the submission stage the applicant (disclosing party) will not express the need to protect the confidentiality of the data contained in the application form and yet the Principal Investigators/Group Leaders of Fondazione Ri.MED (receiving party) ascertains the need to keep data secret, the Principal Investigators/Group Leaders of Fondazione Ri.MED will be responsible to promptly inform the applicant (disclosing party) about the necessity of signing a Non-Disclosure Agreement.
